## Anti-Corruption Commission Recreation Club (ACCRC)

The ACCRC organized a “Maahefun” event to solemnize the blessed month of Ramadan. This event was conducted on 25th April 2019 at the ACC. As part of this special event, a religious lecture was delivered by Dr. Abdul Sattar, Senior Lecturer at Maldives National University. The President of ACCRC, Uz. Mohamed Nishath and Secretary General, Uz. Abdulla Rasheed also addressed the ceremony during this event.





### **UNODC Regional Workshop**

The ACC had participated in the Regional Workshop on Asset Disclosure and Conflict of Interest Systems in South and Southeast Asia organized by the United Nations Office on Drugs and Crime (UNODC). On behalf of the ACC, Legal Officer Uz Safath Habeeb and Assistant Investigation Officer Uz. Adam Shamil attended this Workshop.

This regional workshop took place in Bangkok, Thailand from 11th to 13th June 2019, was aimed to offer the South Asian countries an opportunity to continue with the efforts in furthering the national systems by sharing global and regional trends, country experiences and lessons learned on the effective management of asset declaration and conflict of interest systems for national anti-corruption officials.

### **ACC presented a paper in the Prosecutors' Symposium**

The ACC had participated in the first ever Prosecutors' Symposium held by the Prosecutor General's Office of the Maldives. The main focus of this symposium was to strengthen the criminal justice system. The Commission presented its paper on 16th June 2019 based on the challenges in sending cases to the Prosecutor General's Office for prosecution.

In the panel discussion followed by the presentation, it was discussed about the actions taken so far to solve challenges, more ways to strengthen the investigations and duty prosecution process of corruption cases.

### **Corruption Prevention Training for MIRA Staff**

The ACC had conducted a Corruption Prevention Training Programme for staff of the Maldives Inland Revenue Authority (MIRA) on 22nd June, 2019. The participants were given information regarding corruption and integrity, in the 3-hour session. This session with 21 participants from MIRA was conducted by the expert facilitators of ACC.

### **Training Session at CSTI**

The ACC had conducted an Anti-Corruption Training program for the civil service staff on 26th June 2019, at the Civil Service Training Institute (CSTI). In this 3- hour session, participants were given information regarding corruption and integrity. The session was attended by 50 participants.

### **Training of Trainers (ToT) Programme at Addu City**

The ACC had conducted a Training of Trainers (ToT) Programme at Addu City, Hithadhoo from 27<sup>th</sup> to 29<sup>th</sup> June 2019. A total of 15 trainers participated in this training, including the staff of ACC's South Regional Office.

During this 3 day programme, participants were given information regarding the School Integrity programme and Public Official programme. The Vice President of ACC, Uz. Muaviz Rasheed distributed the Certificate of Completion to all participants in the closing ceremony. All sessions were facilitated by the Vice President, Uz. Muaviz Rasheed and relevant staff of the ACC.

## Trainings and Conferences

### ACRC Training Course

The ACC had participated in the ACRC Training Course for International Anti-Corruption Practitioners organized by the Anti-Corruption and Civil Rights Commission (ACRC) of the Republic of Korea. This training was an all-expense complimented offer by ACRC of Korea. On behalf of ACC Senior Education Officer, Ms. Aishath Sinaau attended this training.

The training program took place in Seoul and Sejong from 13th to 22nd May 2019. It was aimed to help enhance knowledge and capacity required to develop and implement effective anti-corruption policies and measures.

### Seminar on Anti-Corruption for Officials of the Maldives

A delegation of 20 staff from ACC had participated in the 2019 Seminar on Anti-Corruption for Officials of Maldives hosted in Qingdao, China.

The purpose of this workshop is to gain knowledge and experience on procedures and techniques used in China for combating and preventing acts of corruption. Apart from this, the delegation learned about the administrative structure of the Chinese Government and their culture.

Addressing at the opening ceremony, the President Mr. Diao Jiandong from Shandong Foreign Trade Vocational College spoke about the relationship between Maldives and China.

This workshop commenced on 14th May 2019 and was held for a duration of 20 days. The program was initiated and organized by the Shandong Foreign Trade Vocational College with the assistance of Chinese Embassy in Maldives and Ministry of Commerce, China.

### **Publication of Statistics Book 2018**

The ACC had officially published its Statistics Book of 2018. It was released on the evening of 21st April 2019 at the ceremony held to mark the National Anti-Corruption Day. The book was released by the President of Maldives Media Council, Mr. Hidhaayathullah.

Since 2015, the Commission continues to publish its annual statistics book. The main aim of this book is to disseminate timely information to the public and to provide necessary statistics to news reporters, researchers and students. This book consists of, the processes of dealing with complaints, five-year statistical comparison of selected variables and key statistics collected and compiled by the Commission.

### **Publication of White Paper Volume 3, Issue 1**

The ACC had officially released Volume: 3 Issue: 1 of its White Paper series. This policy paper was released on 21st April 2019 at the ceremony held to mark the National Anti-Corruption Day. The White Paper was released by Commission Member, Mr. Yazmeed Mohamed.


The aim of this policy paper series is to disclose corruption risks and provide recommendations on corruption prevention at public sector. The current issue focused on risks of corruption and its prevention in State Owned Enterprises (SOEs). In this regard, the paper highlighted the organizational structure of SOE's, issues in the legal framework of SOE's and risks of corporate fraud. It provided recommendations for overcoming such risks. The paper was also circulated to relevant authorities.

### **Publication of Risk Assessment Report of the Hajj Management System in the Maldives**

The ACC had officially launched risk assessment report of Ministry of Islamic Affairs which studied Hajj Management System in the Maldives. This report was released on 14th May 2019 at a ceremony held at ACC conference room by the Commission Member Mr. Yazmeed Mohamed. The Deputy Minister of Ministry of Islamic Affairs along with members of the ACC, and some Senior Officials from both the institutions attended this ceremony.

The Prevention and Research Unit delivered a presentation highlighting the main risk factors and recommendations identified. Additionally, the Commission Member, Ms. Aminath Minna in her remarks at the ceremony, emphasized the importance of integrity in the hajj management. Further, she stressed the significance of preventing the corruption risk factors in this important system and advised the respective authorities to strictly follow the policies and regulations while implementing the system.

One of the main purpose of this research was to identify the risk factors in the Maldives Hajj Management System and to provide recommendations accordingly. Hence, the research analyzed significant issues and gaps in the related laws and regulations; quota distribution among pilgrimage service providers, bid evaluation process, concerns about Mutawif and Hajj Missions.

### **Publication of Story book**

The story book of the Inter-School Integrity story production competition was launched on the special ceremony held to mark the National Anti-Corruption Day. The books were officially launched by the Commission Member, Ms. Aminath Minna. In addition, plaques and certificates for the best 10 stories of the competition were also presented by Ms. Minna.

Plaques, certificates and monetary rewards were awarded to the best 3 stories of the competition and certificates were awarded to the judges by the President of Civil Service Commission, Dr. Ali Shameem.

A total of 42 stories were submitted by a total of 28 schools. The stories are based on characteristics of integrity, targeted to children of foundation level. The best stories of this competition will be printed and distributed to schools.
